1.0 PENGENALAN

Treasury Authentication System (TERAS) menyediakan platform pengesahan pengguna melalui kaedah berikut :

2.1 DAFTAR AKAUN

1. Bagi mendaftar pengguna, klik pada **Daftar Akaun** dan sistem akan memaparkan **Akaun Pendaftaran Pengguna / User Account Registration** pada skrin.


